WARNING

DISASSEMBLY: Take all necessary precautions as outlined in your Service Manual to insure a safe and stable motorcycle during removal and installation of these parts.


- 1. Disconnect the negative (ground) battery lead and safely pull to the side.
- 2. 2.Remove your pillion seat and driver's seat per the Harley Davidson® Service Manual, followed by removal of seat grab rail. Carefully lay the grab rail against the gas tank. Use a blanket or towel to protect the paint.




3. Disconnect the left and right side marker light connectors, as well as the license plate illuminator connector.



4. Remove the (4) 6mm screws fastening the oem license plate bracket to the subframe.



- 5. Remove the license plate bracket and place on your bench. Cut the zip ties holding the wires to the plate bracket. Unscrew the "P" connectors. These will not be reused.
- **6.** Using an 8mm socket, remove the two screws attaching the license plate illuminator hood to the plate bracket. Remove the Light and hood.







8. Remove each side marker light. PLEASE NOTE: Side marker light stalks will NOT be reused.

INSTALLATION: Pay close attention to the order of assembly, as improper installation order will prevent flawless performance of this part.

1. Position each side marker light in its respective position. Take note of the bar and shield orientation. Attach each side marker light using supplied M6 buttonhead screws. PLEASE NOTE: Side marker light stalks will NOT be reused. Apply a small drop of blue thread locker. Torque to 8ft/lbs.



2. Pass the wiring pigtail from the illuminator through the new Bare Knuckle Performance License Plate Relocation Bracket from the bottom side.



- 3. Carefully clean the top side of the illuminator, as well as the surface under the illuminator hood with rubbing alcohol.
- **4.** Affix the supplied 3M adhesive backed rubber to the top side of the illuminator.
- **5.** Position the illuminator under the hood of the bracket, and permanently affix.



- 6. Using the supplied M8 flanged screws, place one spacer between the top side of the plate bracket, and the under side of the rear most frame lug. Apply a drop of blue thread locker to each screw, and torque to 19ft/lbs.
- 7. Reattach side marker lights pigtails to their respective plugs. Reattach license plate illuminator plug. It is a good idea to use a small zip tie to fasten wiring in a safe location.
- 8. Place the under-seat cover plate over the two large holes in the subframe. With the supplied M6 nuts and screws, fasten the plate using the 4 bolt locations that previously held the oem license plate bracket to the subframe. Use a small drop of blue thread locker on each screw and nut. Torque to 8ft/lbs.



- 9. Reinstall seat grabrail using original bolts. Use thread locker and torque to factory specs per Harley Davidson Service Manual.
- 10. Reinstall driver seat and pillion seat.
- 11. Reconnect battery ground.
- 12. Test side marker and license plate illuminator lights.
- **13.** ENJOY!
